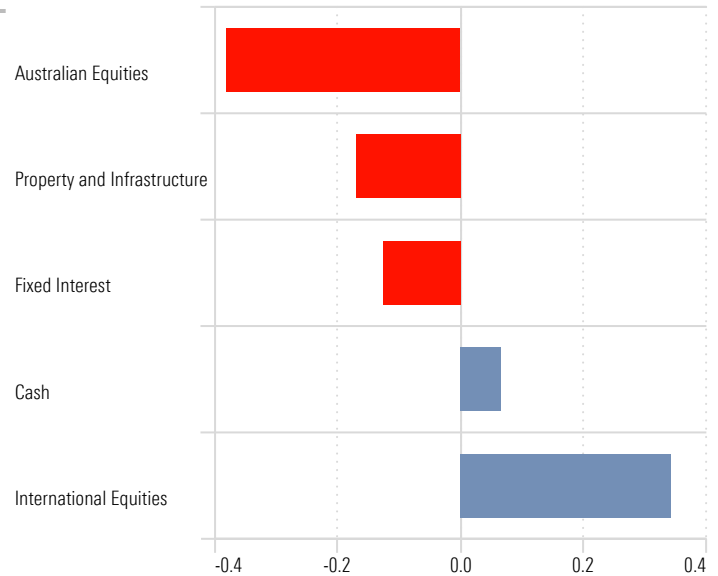

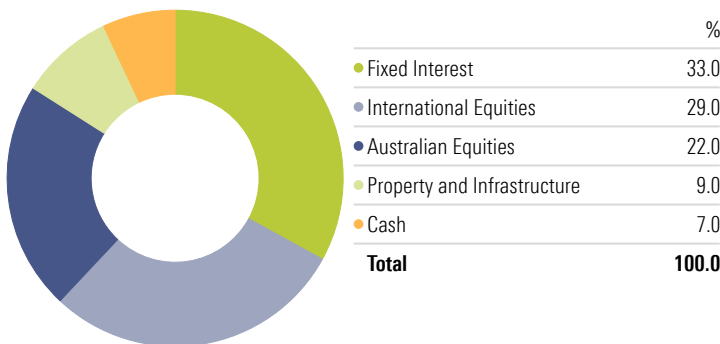

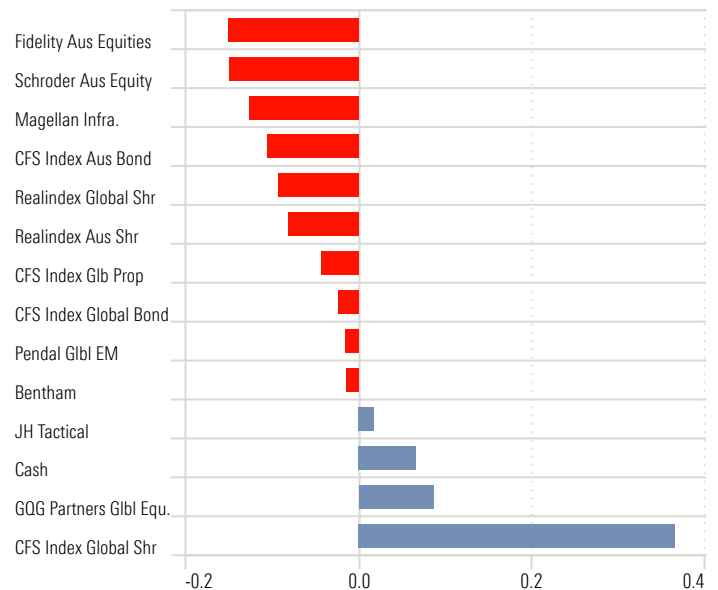
Sector Allocation

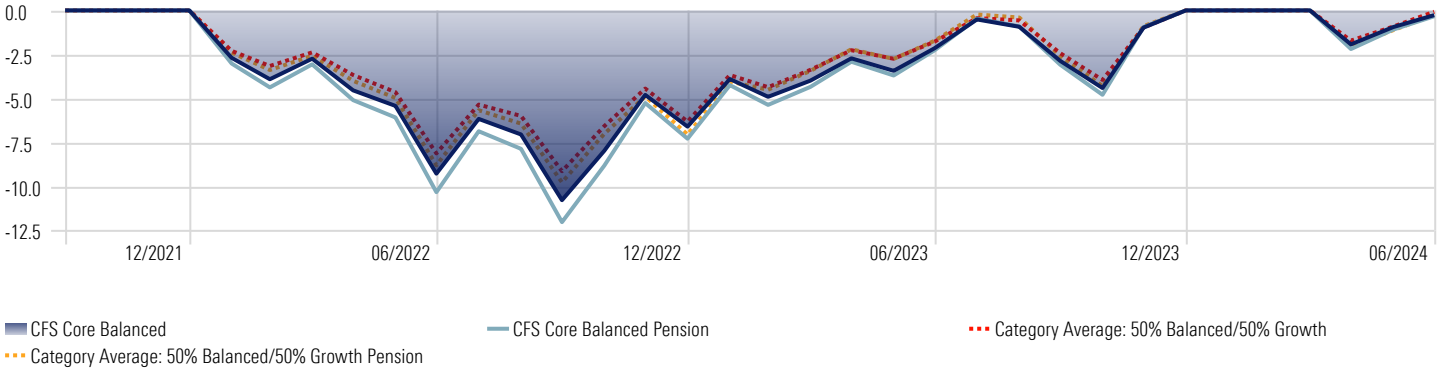

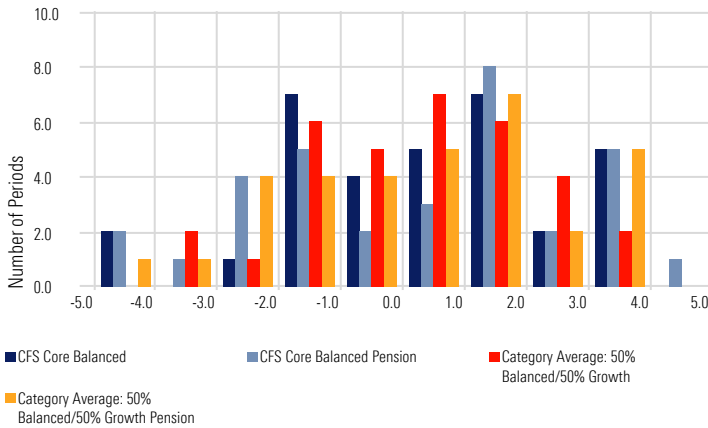
Drawdown

Time Period: Since Common Inception (1/10/2021) to 30/06/2024



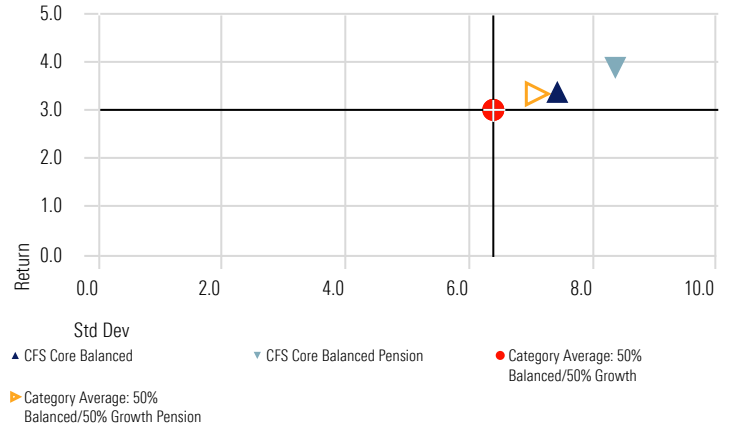
Return Distribution

Risk-Reward

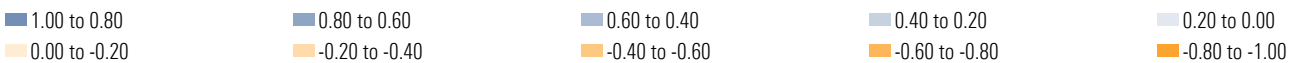
Time Period: Since Inception to 30/06/2024
