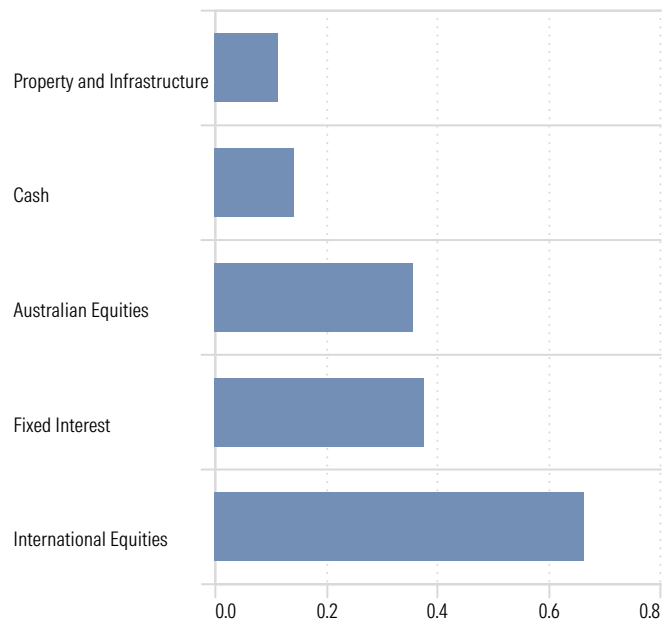

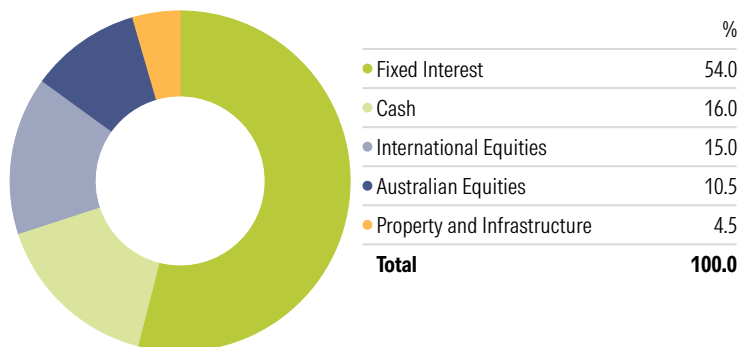
Asset Class Quarterly Contribution to Performance

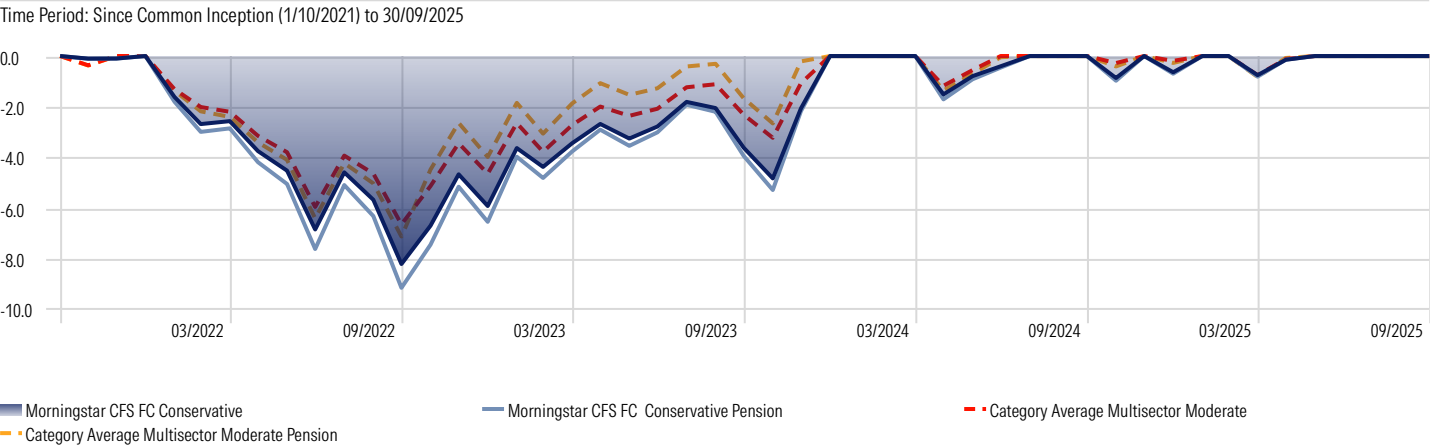

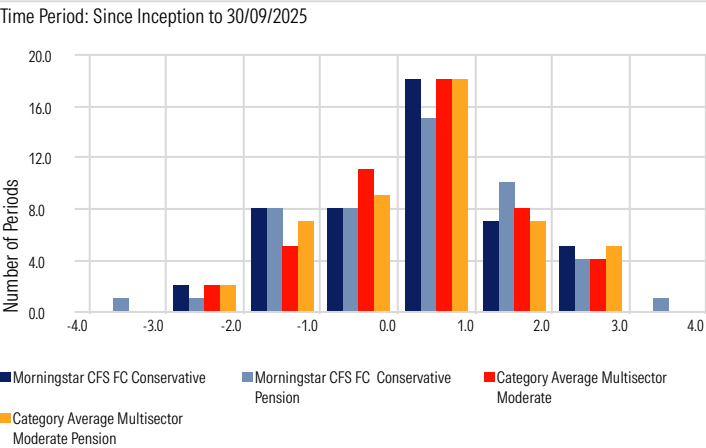

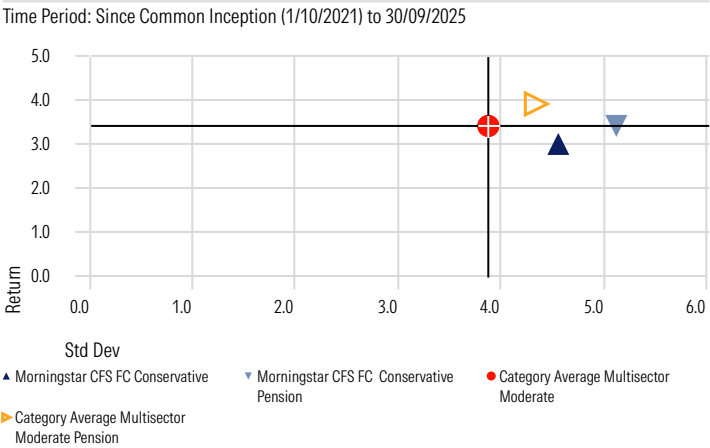
