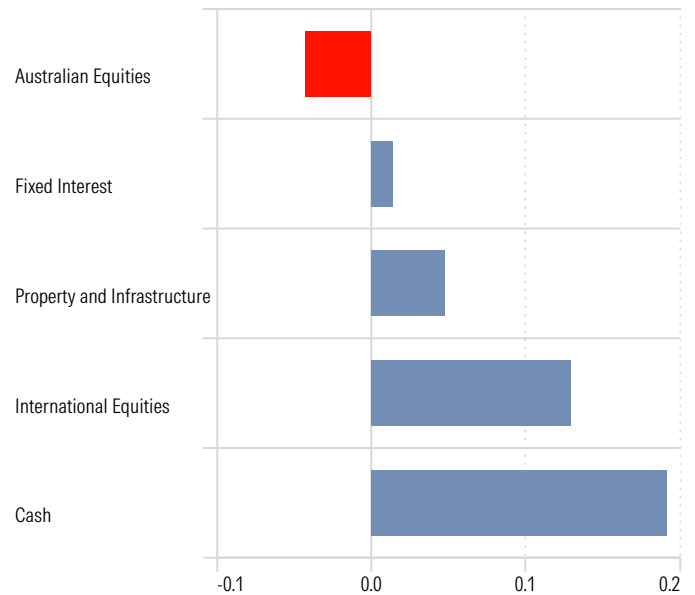

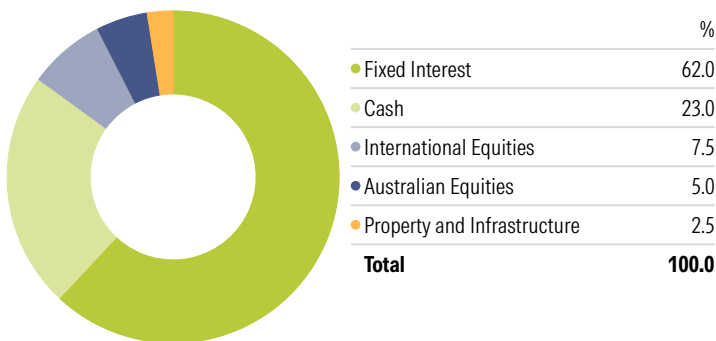
Asset Class Quarterly Contribution to Performance

Time Period: 1/10/2025 to 31/12/2025



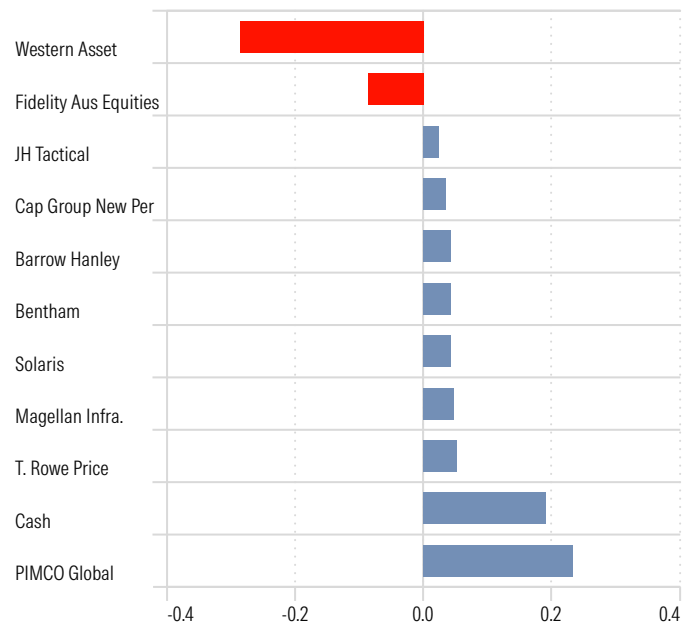
Sector Allocation

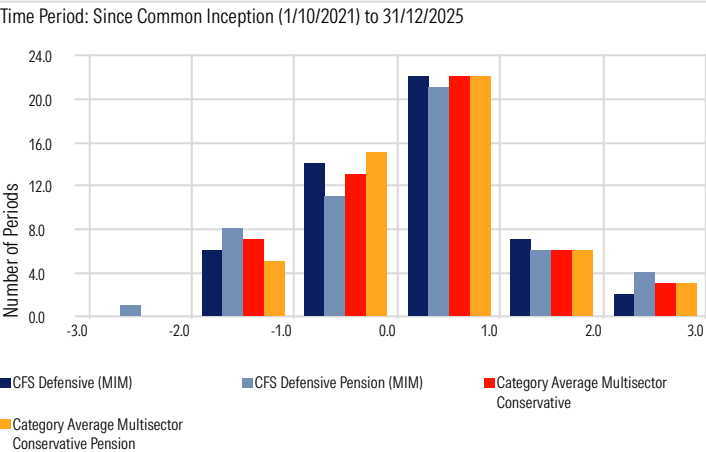

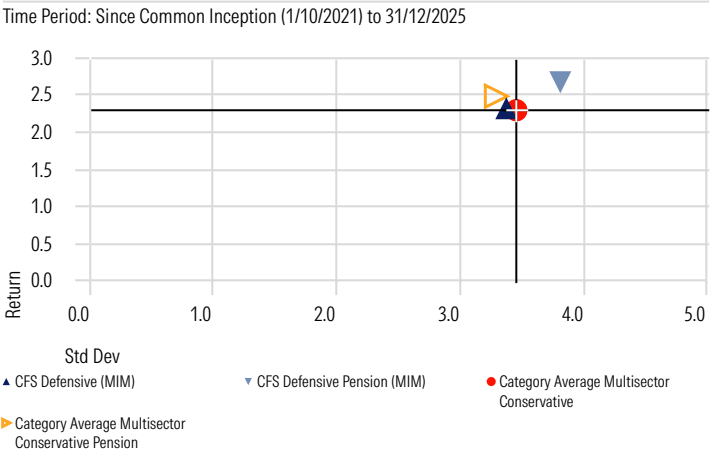

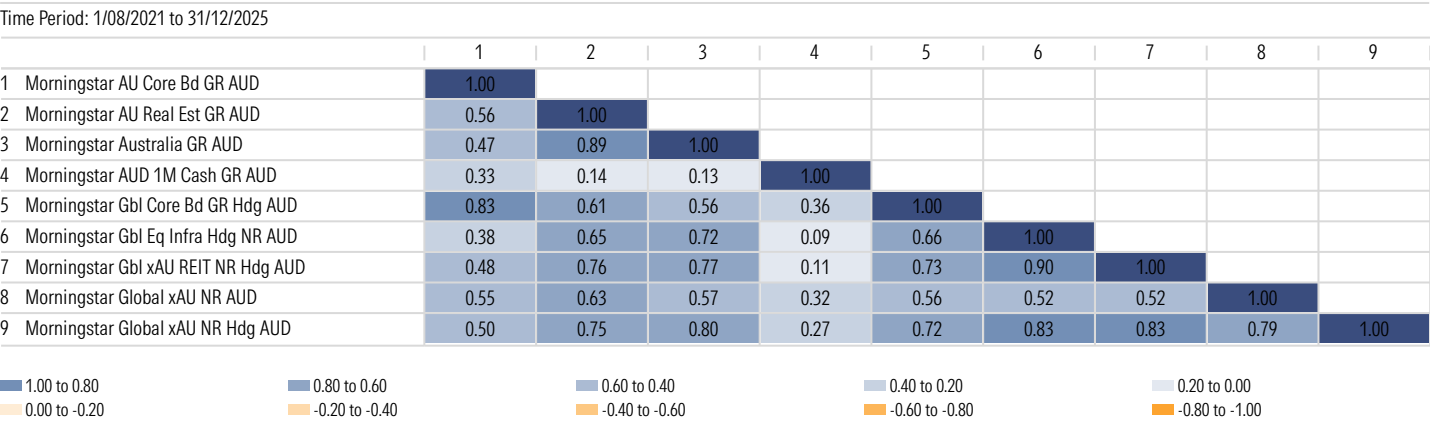
Return Distribution
