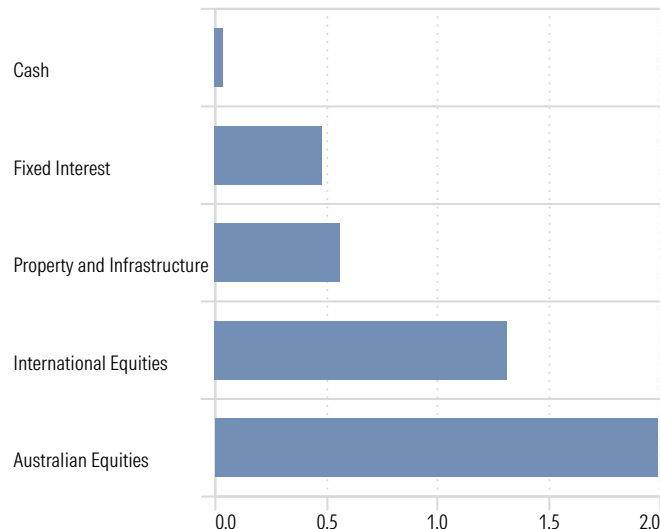

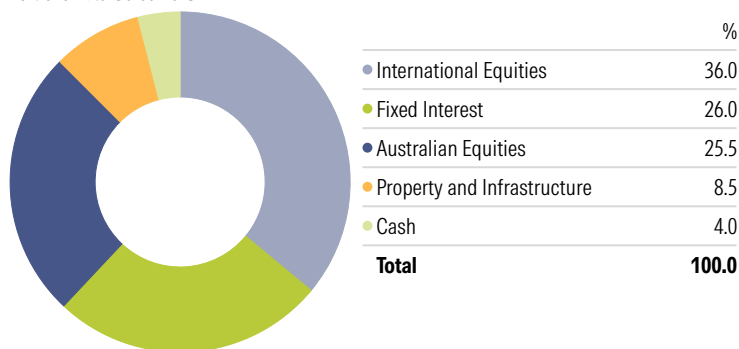
Asset Class Quarterly Contribution to Performance

Time Period: 1/04/2025 to 30/06/2025



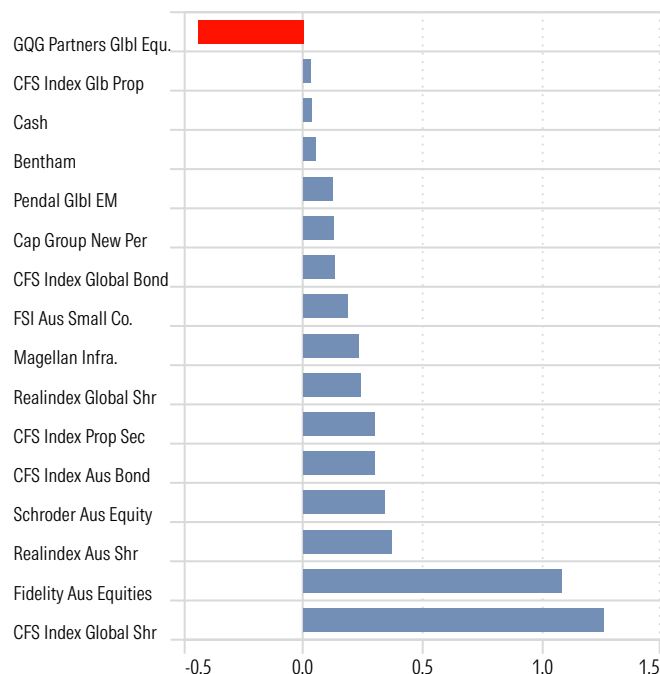
Sector Allocation

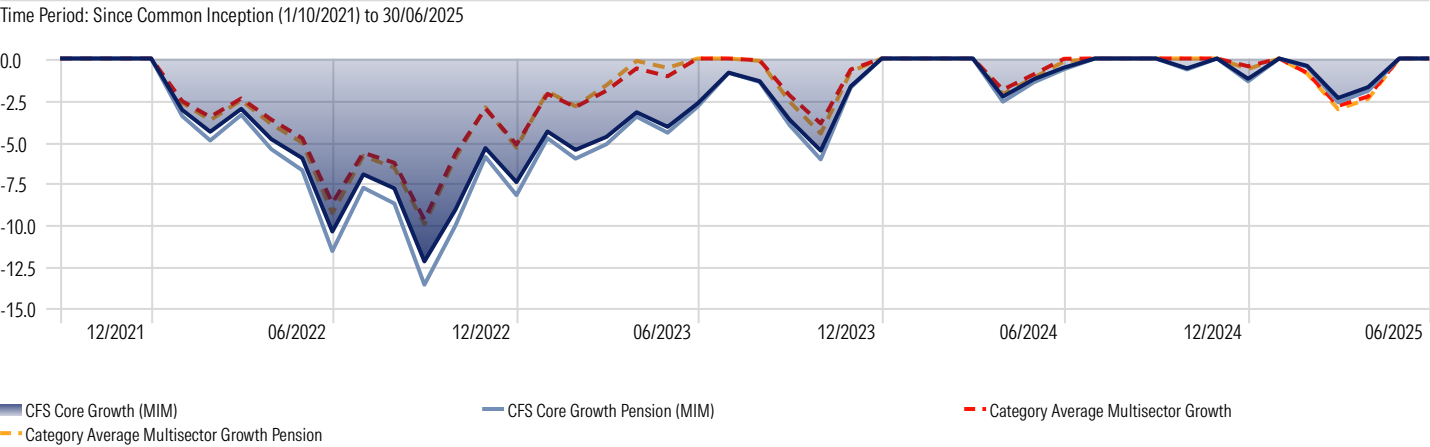

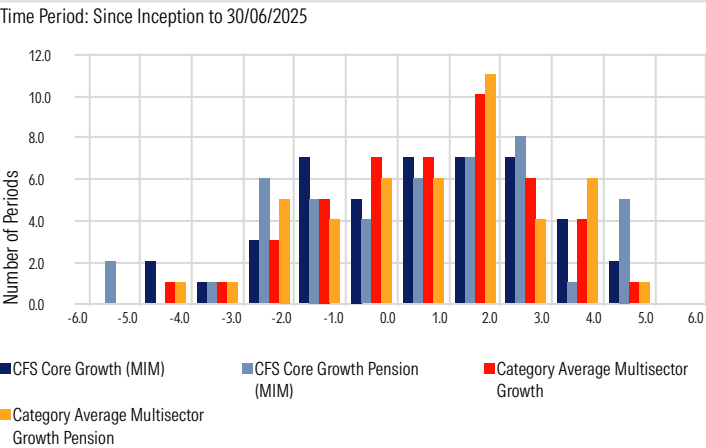

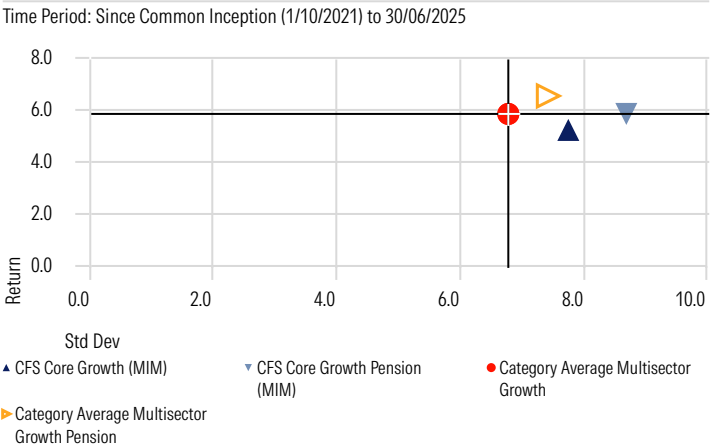
Drawdown
