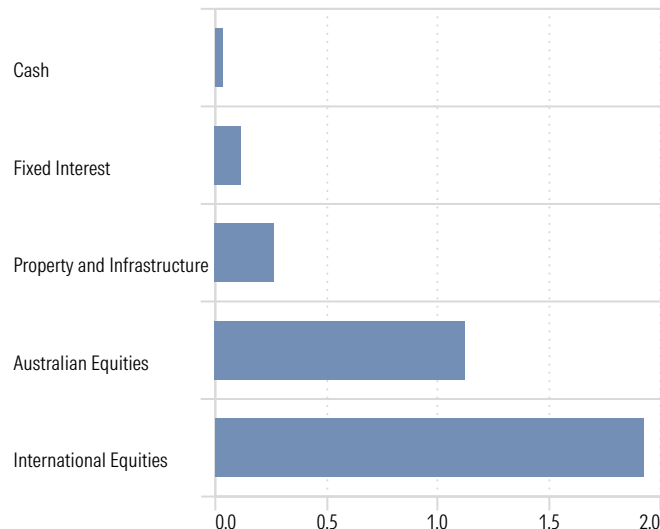

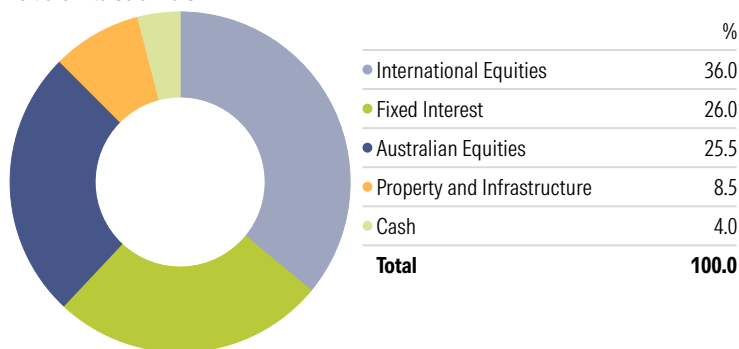
Asset Class Quarterly Contribution to Performance

Time Period: 1/07/2025 to 30/09/2025



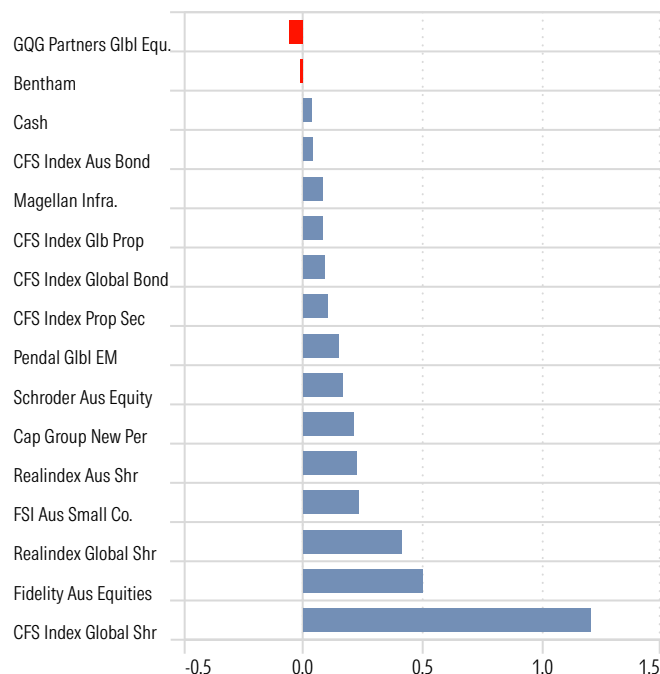
Sector Allocation

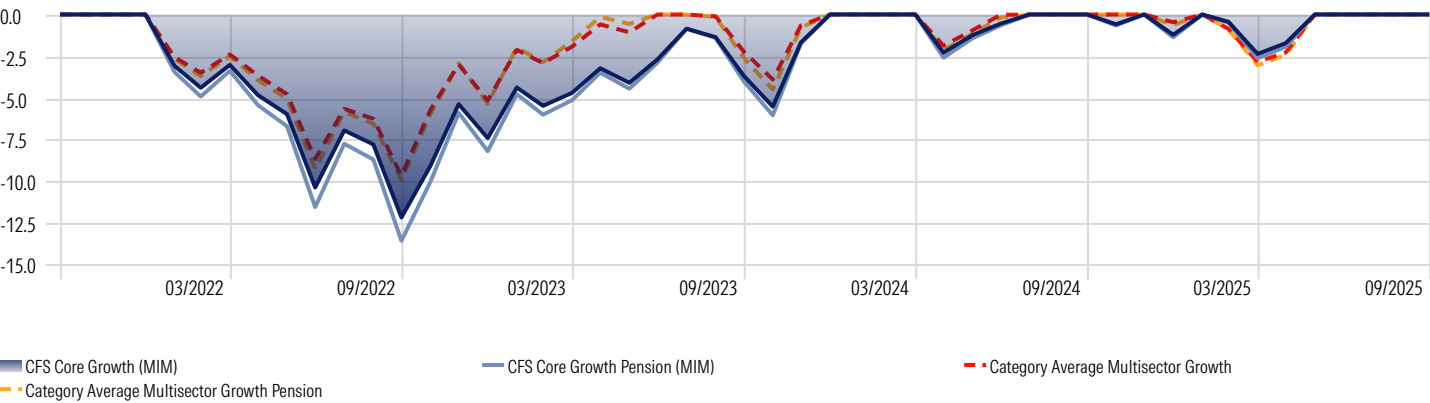

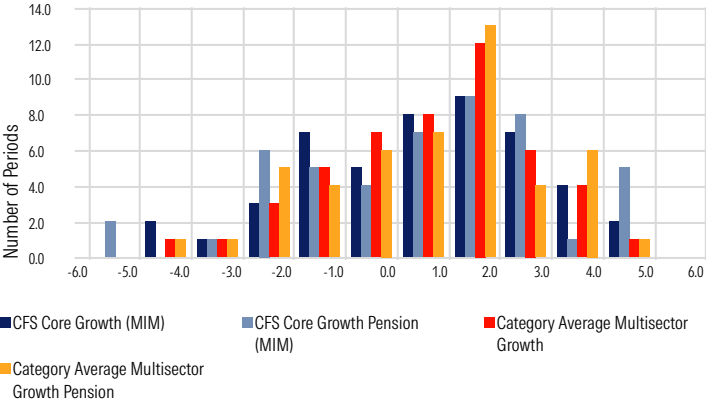
Drawdown

Time Period: Since Common Inception (1/10/2021) to 30/09/2025



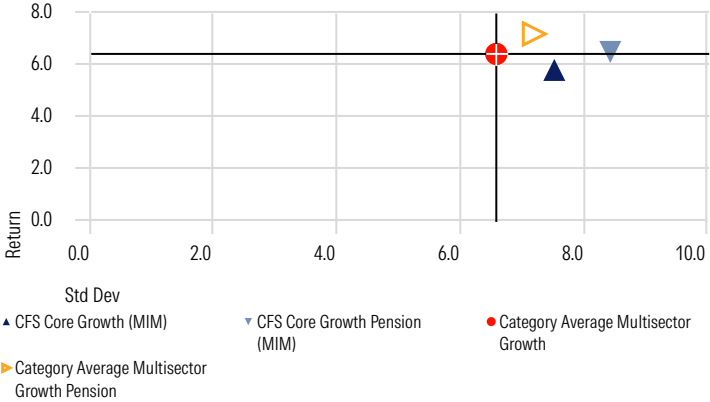
Return Distribution

Time Period: Since Inception to 30/09/2025



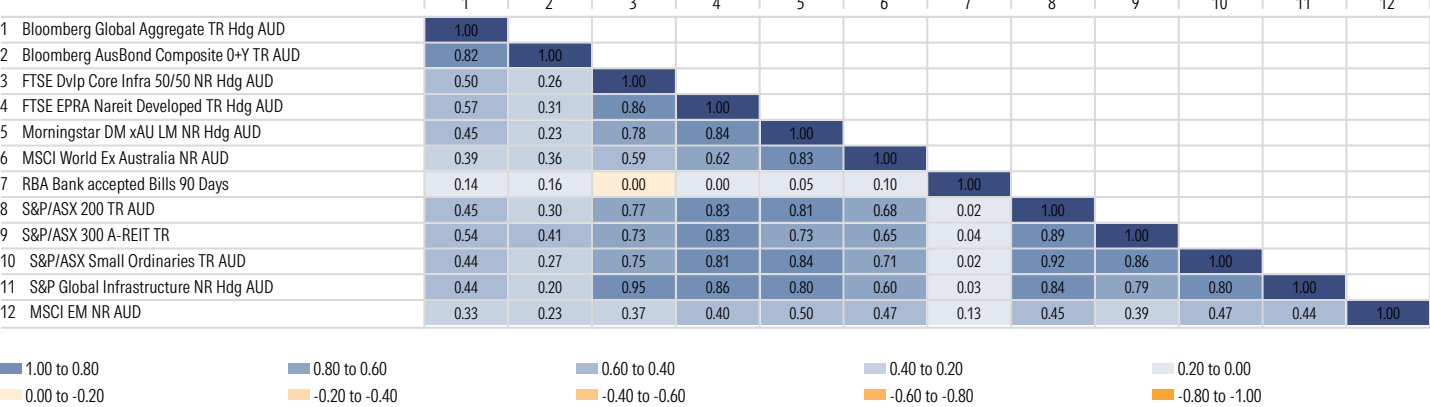
Risk-Reward
