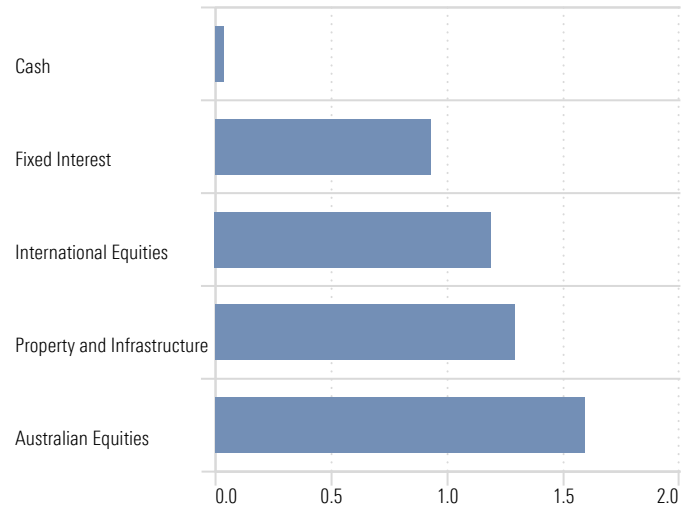

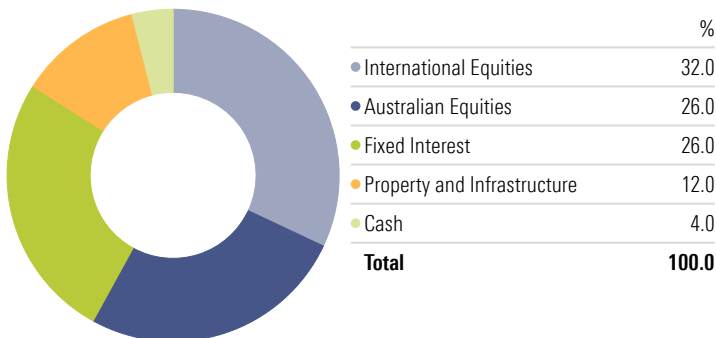

Time Period: 1/10/2023 to 31/12/2023

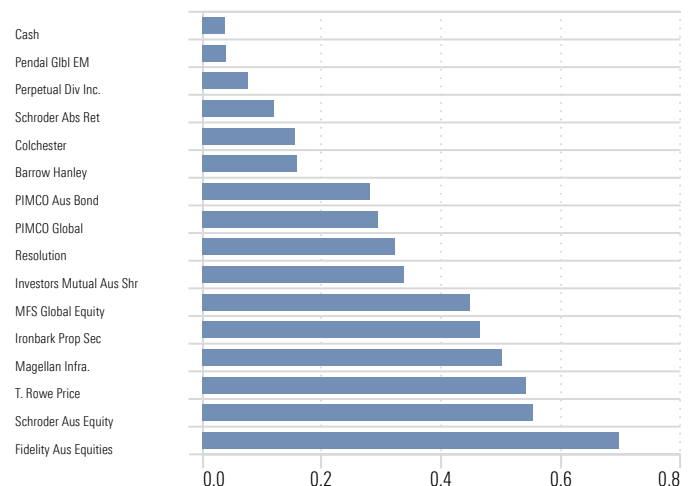


Sector Allocation

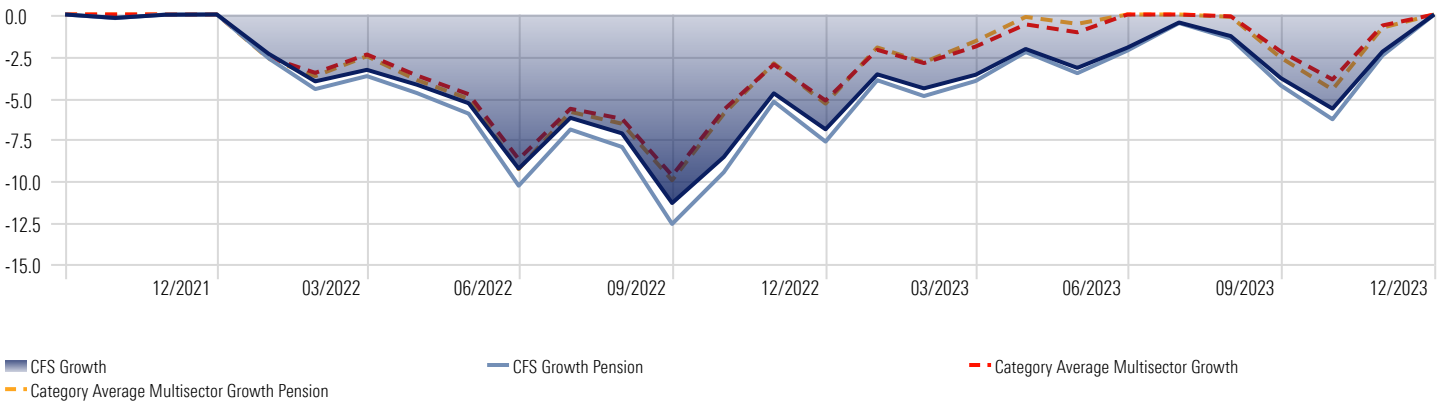

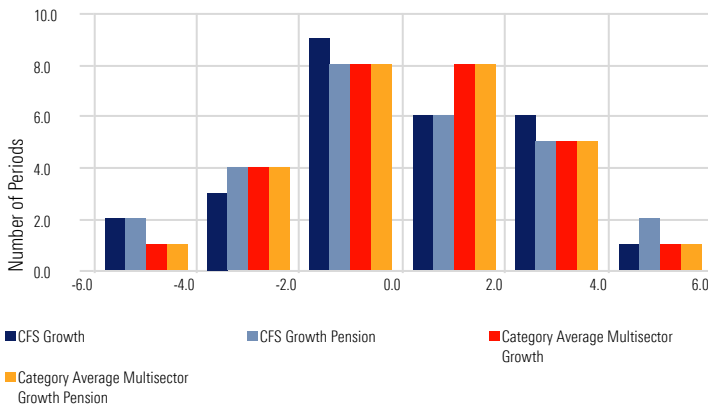
Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/12/2023



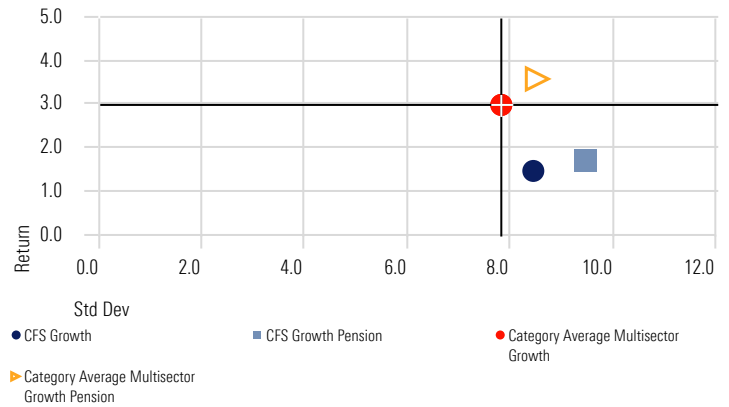
Return Distribution
