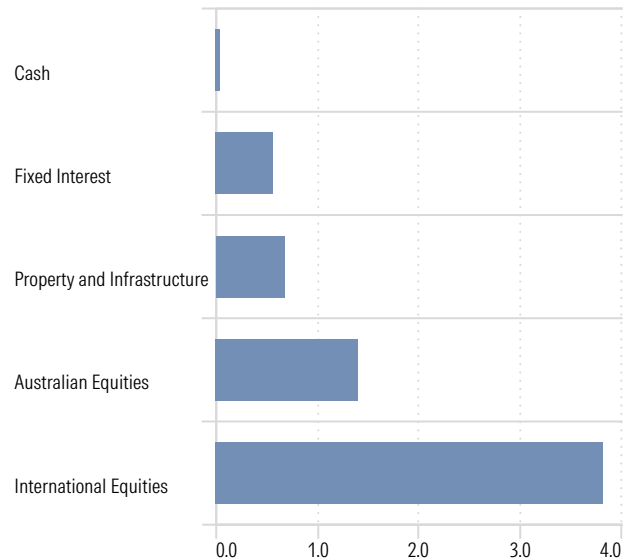

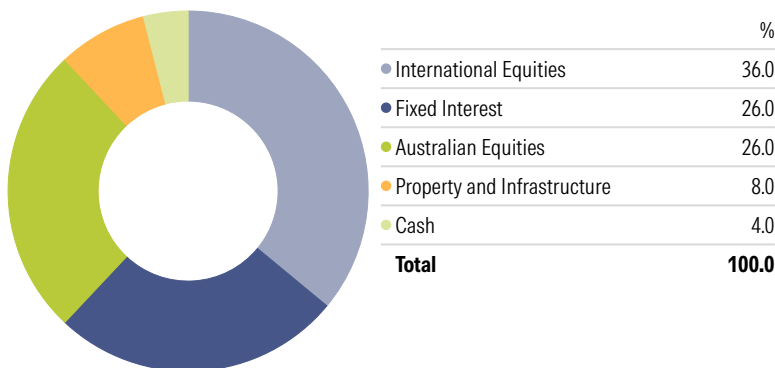
Asset Class Quarterly Contribution to Performance

Time Period: 1/04/2026 to 30/06/2026



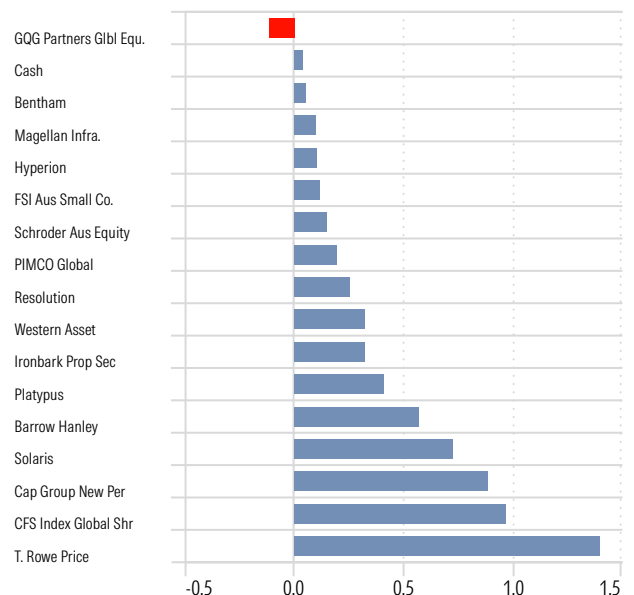
Sector Allocation

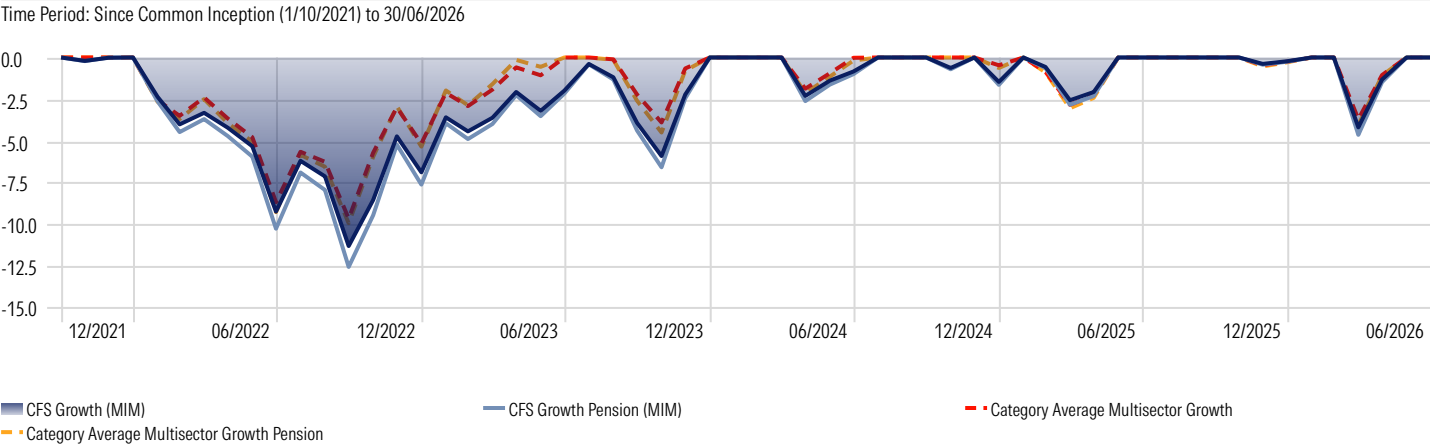

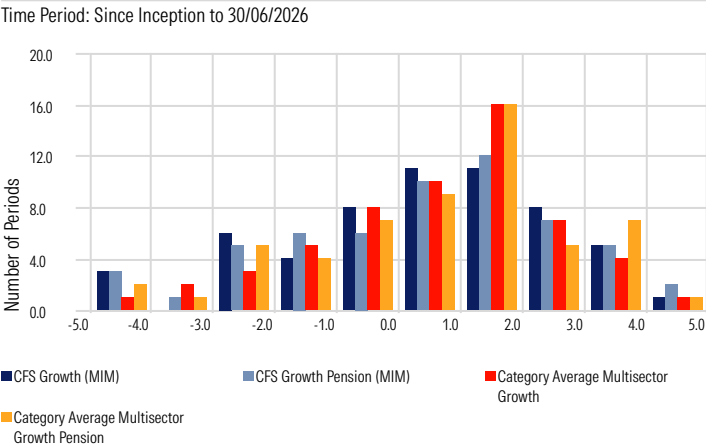

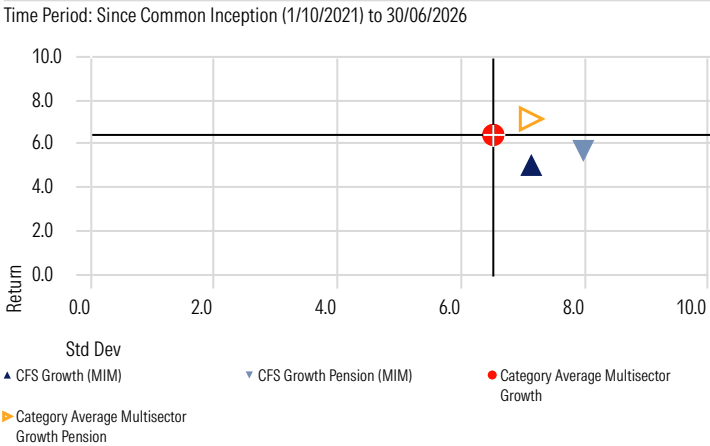
Drawdown
