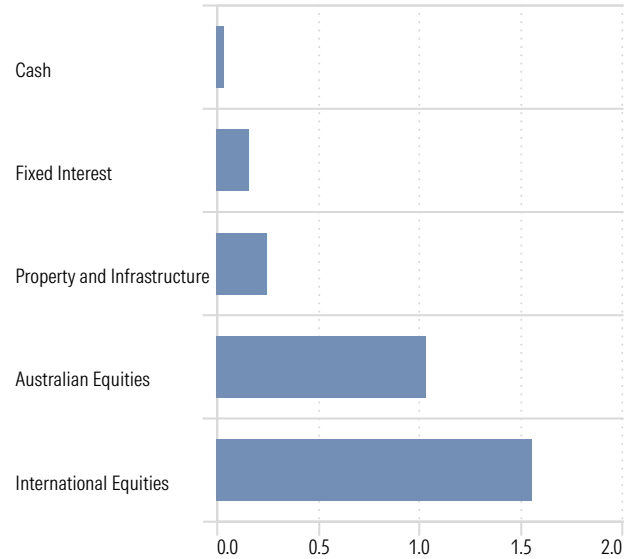

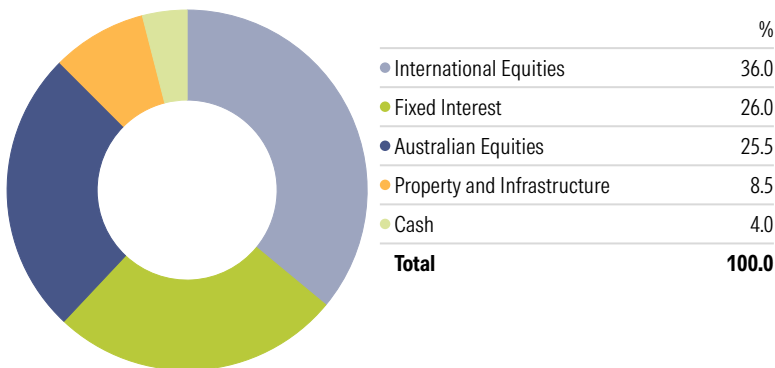
Asset Class Quarterly Contribution to Performance

Time Period: 1/07/2025 to 30/09/2025



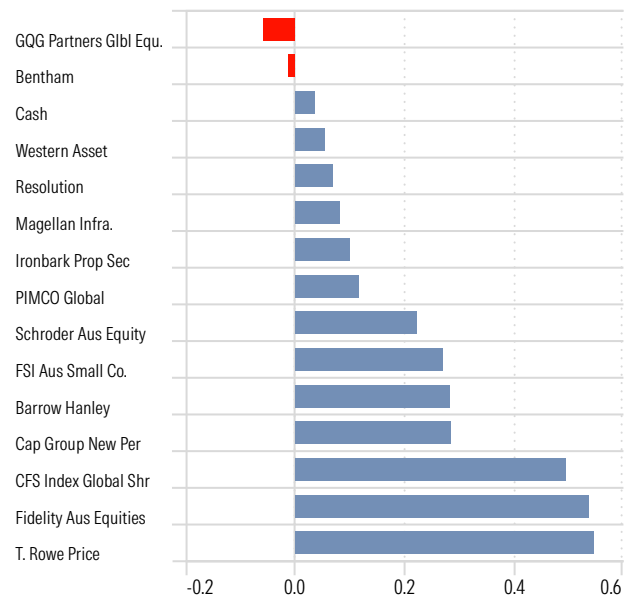
Sector Allocation

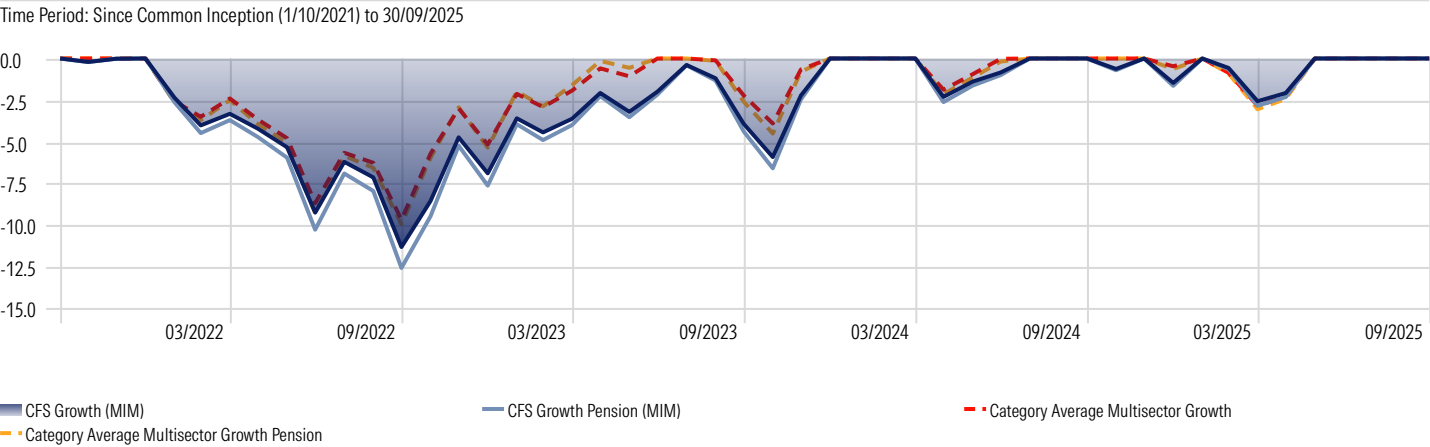

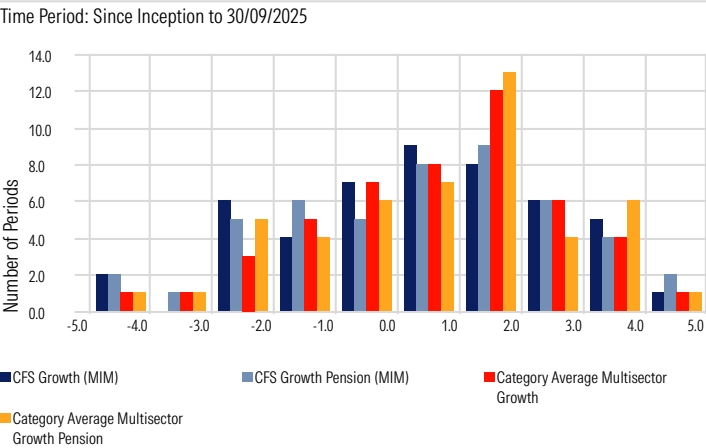

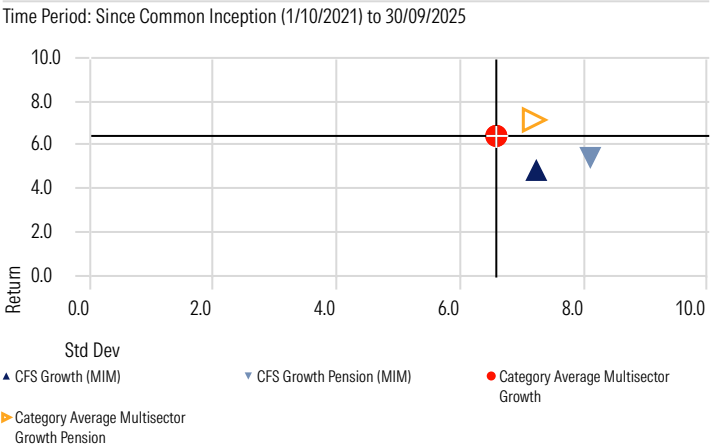
