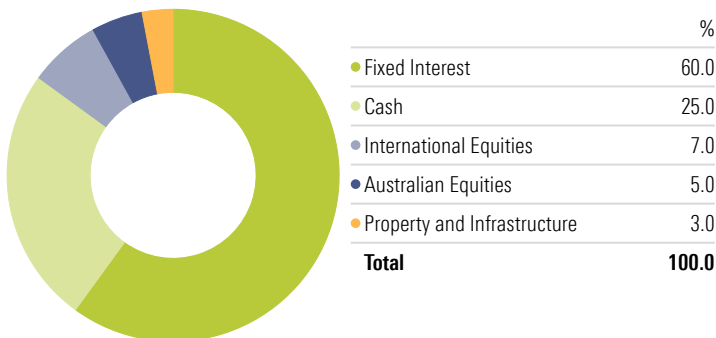

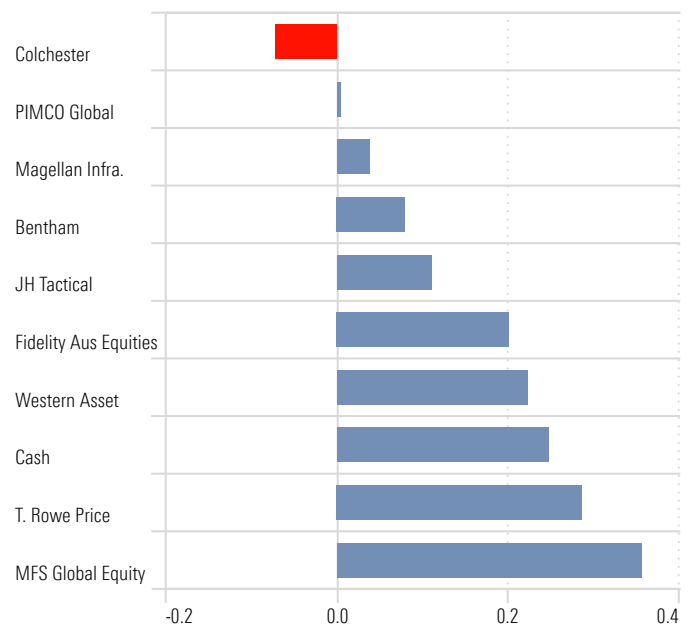

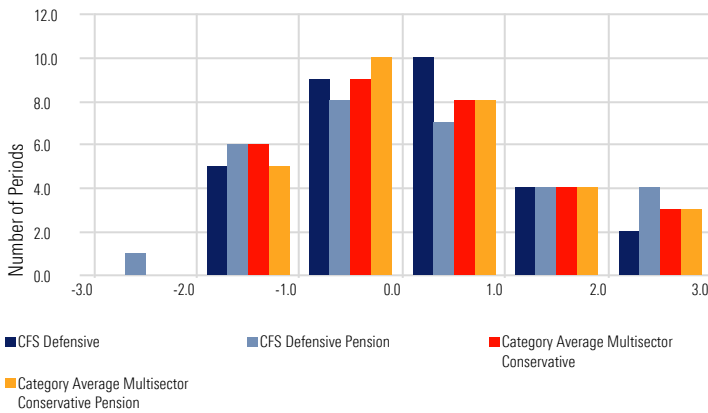
## Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/03/2024



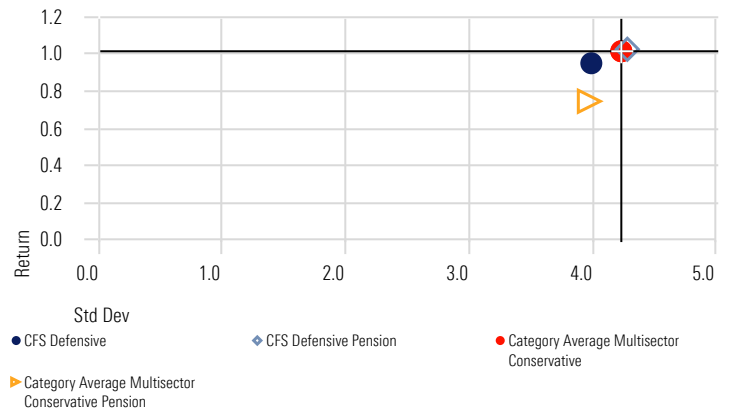
## Return Distribution

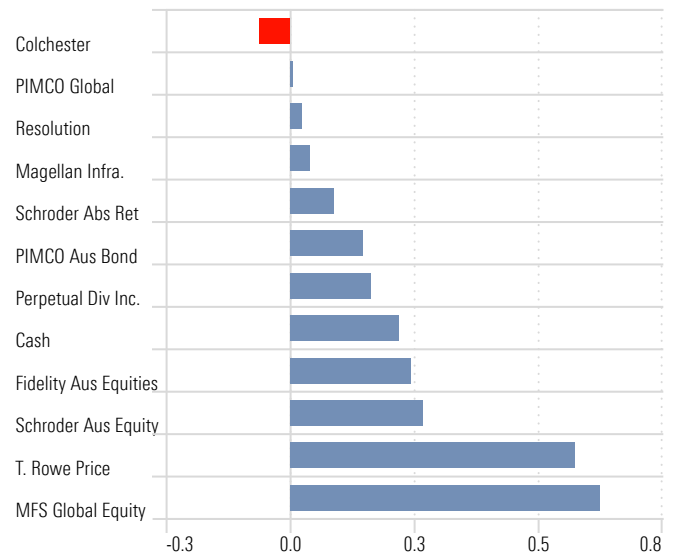

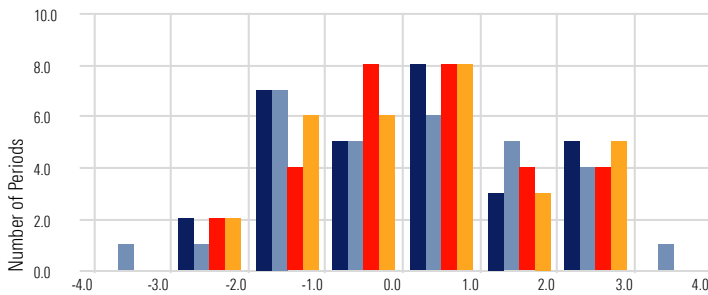

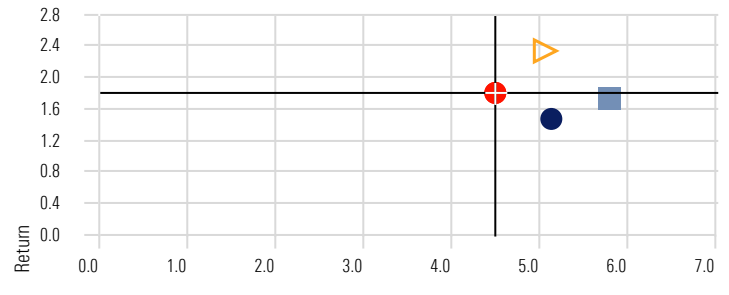

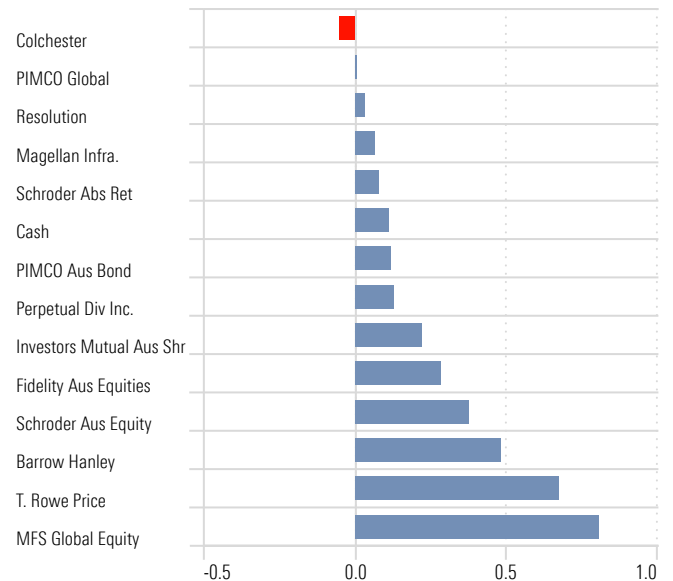

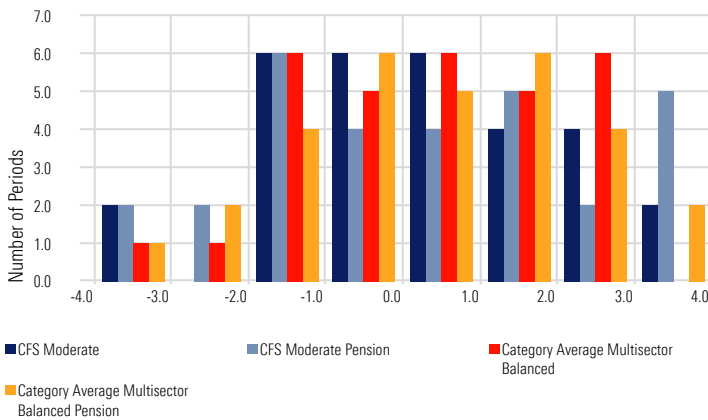
## Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/03/2024



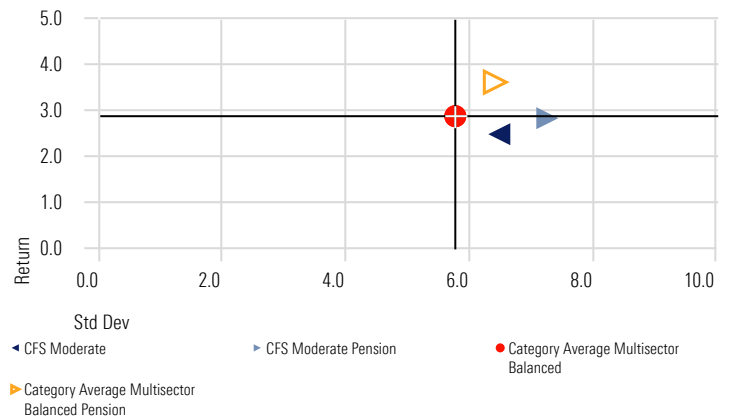
## Return Distribution

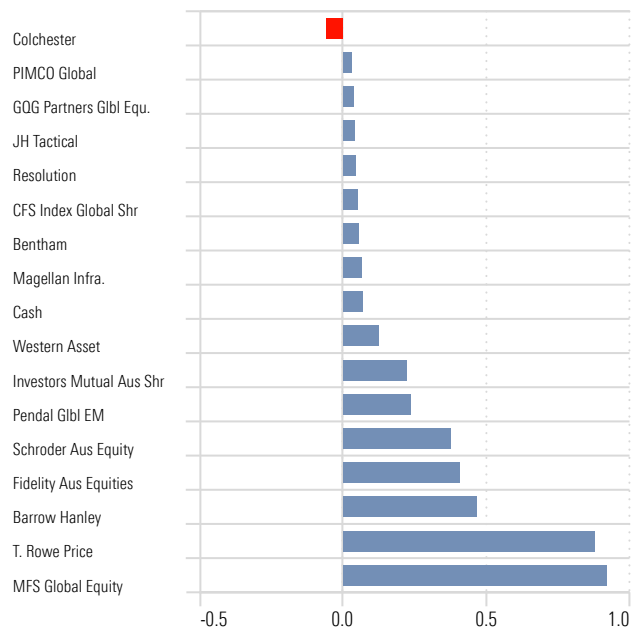

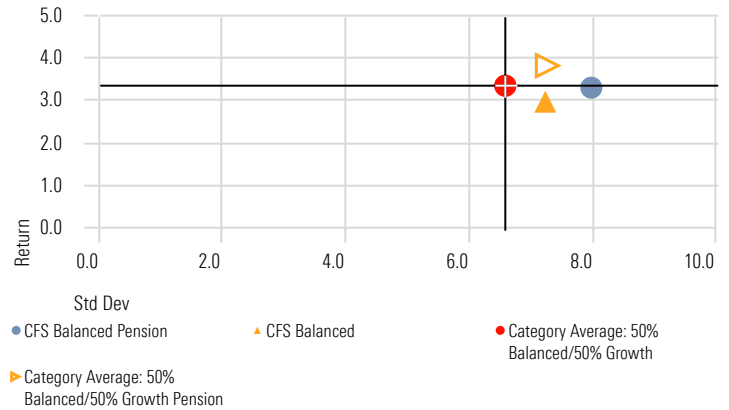
## Return Distribution

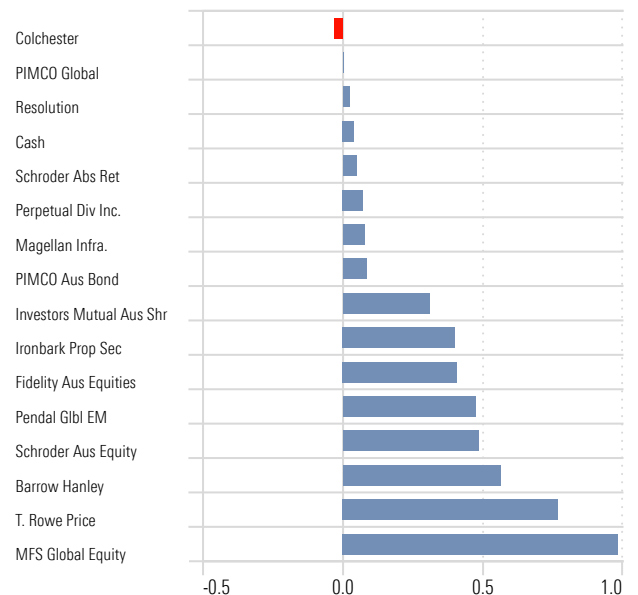


### Sector Allocation

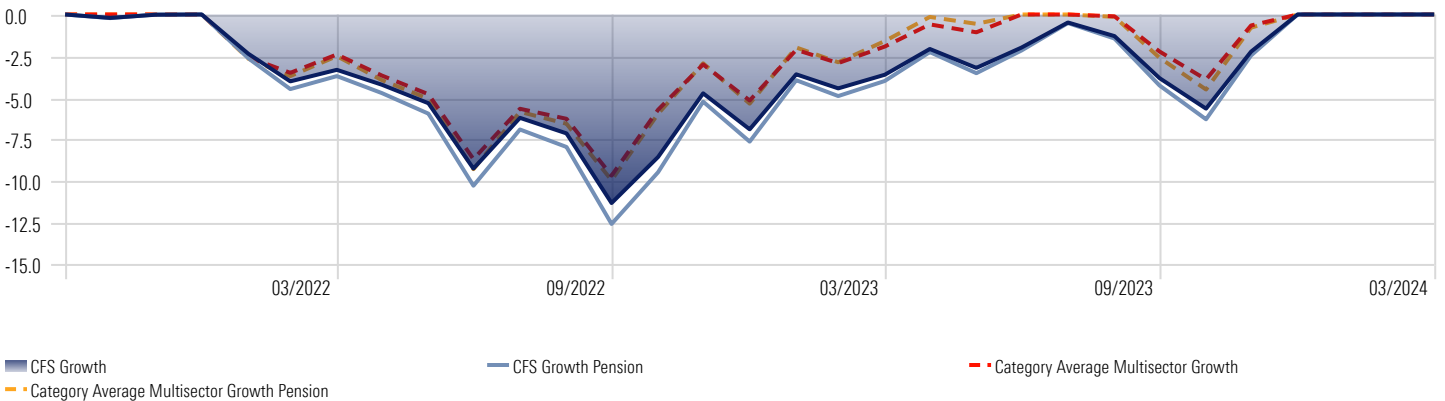

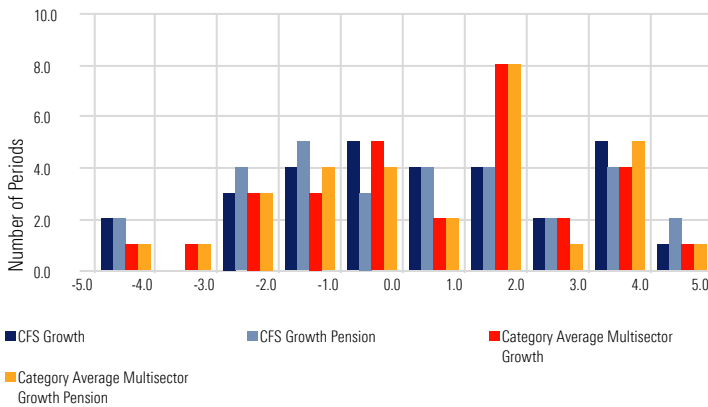
## Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/03/2024



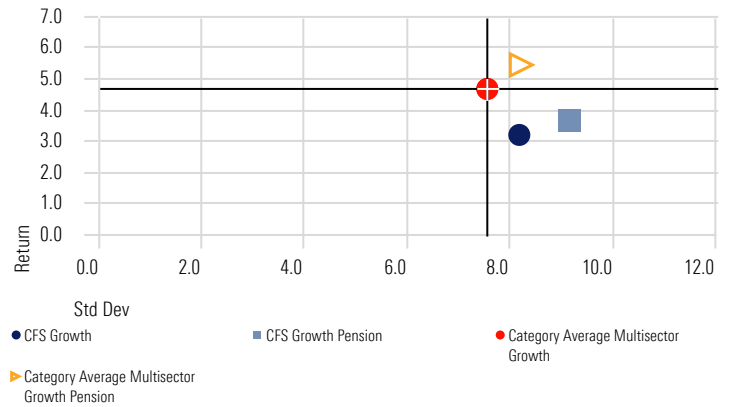
## Return Distribution

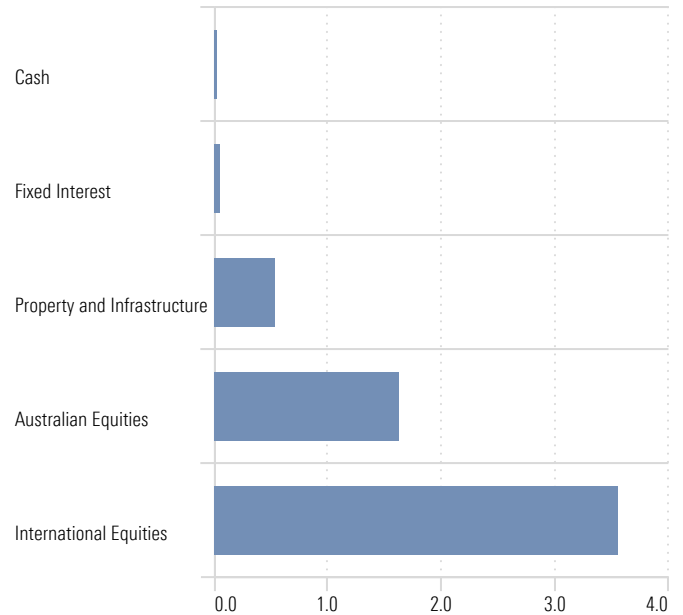

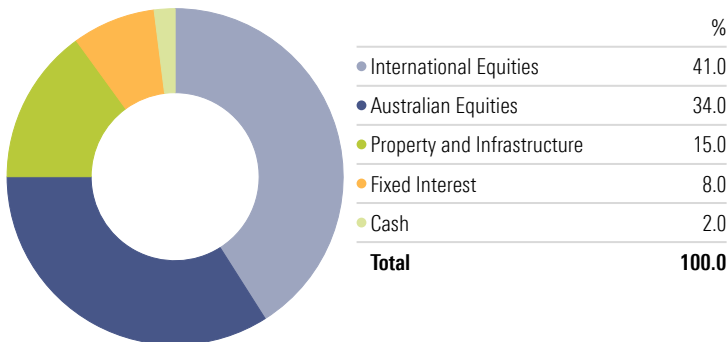

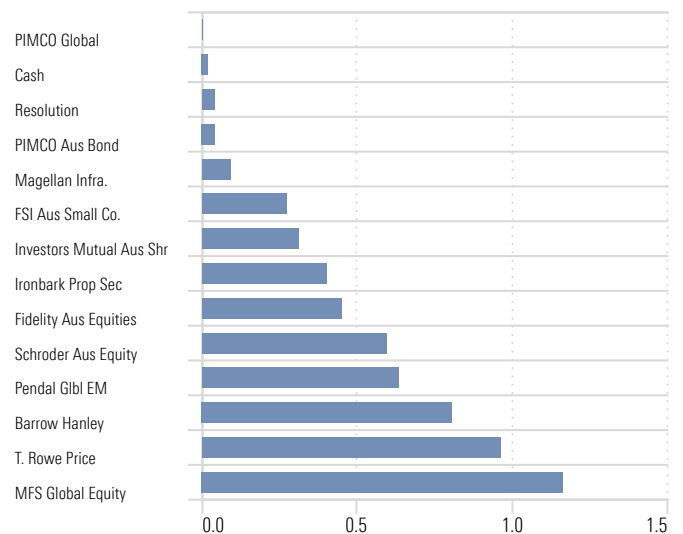


### Sector Allocation

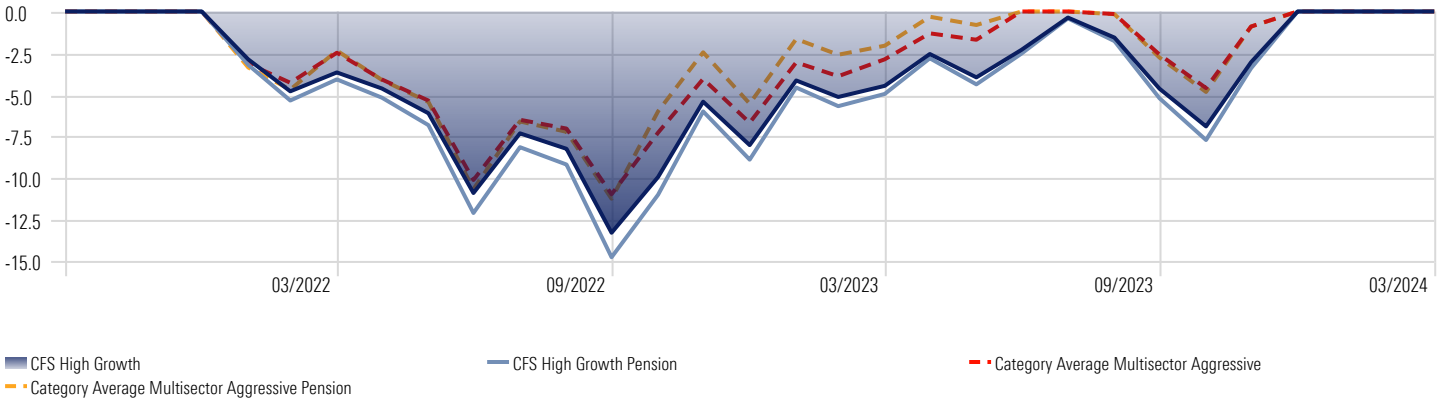

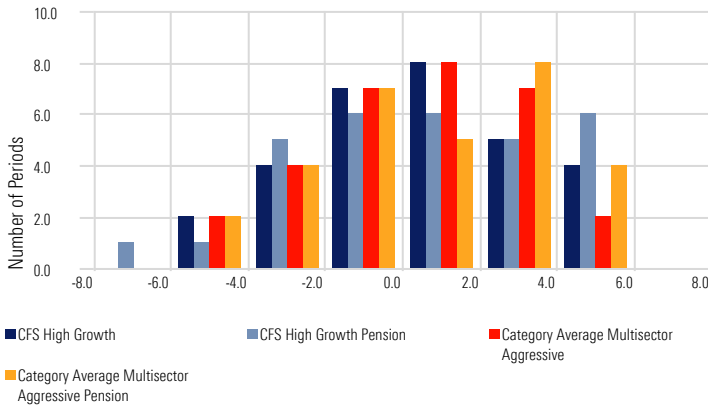
## Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/03/2024



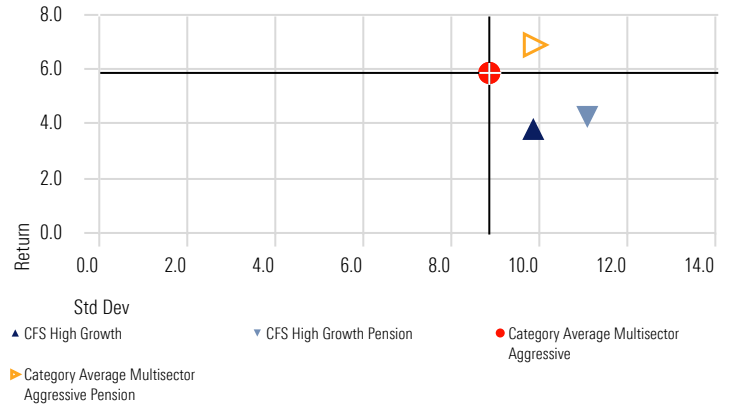
## Return Distribution
