


Asset Class Quarterly Contribution to Performance

Time Period: 1/10/2024 to 31/12/2024




Sector Allocation






Return Distribution










Asset Class Quarterly Contribution to Performance




Return Distribution



Time Period: Since Common Inception (1/10/2021) to 31/12/2024




Return Distribution






Asset Class Quarterly Contribution to Performance

Time Period: 1/10/2024 to 31/12/2024




Sector Allocation






Asset Class Quarterly Contribution to Performance






Drawdown

Time Period: Since Common Inception (1/10/2021) to 31/12/2024




Return Distribution
